We grade all of our homes between $1 \ddagger$ and $5 \ddagger$, to give you an idea of their quality and popularity. All our homes are at least $4 \ddagger$, and we will upgrade any $3 \ddagger$ homes before they are re-let

Demand Effect

A $3 \ddagger$, $4 \ddagger$ or $5 \ddagger$ home can be rated in the star category above or below its quality rating based on demand as follows:

Demand Effect	Change	Criteria
****-	5 ★ to 4 ★	$5\star$ property with anticipated demand of under 30 applicants
****+	4 ★ to 5 ★	$4\star$ property with anticipated demand of over 100 applicants
****-	4★ to 3★	$4\star$ property with anticipated demand of under 30 applicants

Anticipated demand is the number of applications we expect to get when the property is advertised for rent. This is based on our experience and previous demand for similar properties in that area.

1 \star , 2 \star and 3 \star homes are not given demand weighting since we aim to have all our homes reach 4 standard as a minimum.

Using the Star Grades

The star grade we give is intended only to give a general indication of the quality and likely demand for that house. The grading is not linked to the rental charge for the property, and the information we give is accurate to the best of our knowledge. The rating may be based on a similar property in the same area rather than an assessment of the individual property, therefore we cannot guarantee that any particular house meets all of the criteria we have set out.
