

DWP Benefit Update

The Government is increasing benefits in line with inflation by 10.1%. Working age families will see their benefit payments rise from April 2023. The Government is also providing support this winter for people who need help now, including money off energy bills and Cost of Living Payments.

Pensioners in Great Britain will benefit from a 10.1% increase to their State Pension in April 2023. A full basic State Pension will increase from £141.85 to £156.20 each week, and the new State Pension will increase from £185.15 to £203.85. Pension Credits will also increase by 10.1% in April 2023.

UK households on means-tested benefits will receive an additional Cost of Living Payment of £900 in 2023-24. This will be made in more than one instalment.

People across the UK on non-meanstested disability benefits will receive a further £150 Disability Cost of Living Payment in 2023-24, to help with the additional costs they face. This is in addition to the Cost-of-Living Payments for households on means-tested benefits and pensioner households, if eligible.

Pensioner households across the UK will receive an additional £300 Pensioner Cost of Living Payment in 2023-24 to help with bills. This is in addition to meanstested benefits and disability payments, if eligible.

In April next year the benefit cap will also increase by 10.1%.

We will keep you updated with additional information as it is announced.

Recoverable Hardship Payments

If you have applied to the DWP to stop your Recoverable Hardship Payment (RHP) payments and they refused, you can now re-apply to have this decision assessed.

Recoverable Hardship Payments give money to people who have seen their benefits reduced by sanctions or a fraud penalty. You must apply for them with evidence of need, and each request is reviewed individually. You can request for the recovery of these payments to be waived (stopped), and must provide evidence to show that paying back the money is either unaffordable or would affect you or your family's health or wellbeing.

An exercise has been started to look at previous waiver requests that took place prior to 11 January 2021. A guidance page on GOV.UK explains the process and asks claimants to share evidence if they feel their RHP should be waived.

Applications can only be considered if a request was made to waive the RHP between 1 January 2014 and 11 January 2021 and was refused at the time.

Applications will open on 19 December 2022.

Benefit Update for Parents



Scottish Child Payments Extended

The Scottish Child Payment will be extended to all under 16-year old's from 14 November 2022 and the payment will increase from £20 to £25 each week for families in receipt of the following qualifying benefits:

- Universal Credit
- Child Tax Credit
- Working Tax Credit
- Pension Credit
- Income Support
- Income-based jobseeker's allowance (JSA)
- Income-related employment and support allowance (ESA)

It is necessary to apply for the Scottish Child Payment. Claims can be made online at **mygov.scot** or by phone **0800 182 2222**.

Scottish Child Payment Bridging Payment

The fourth and final Scottish Child Payment Bridging Payment due in December, is to be doubled from £130 to £260. This payment is made automatically by East Lothian Council to families for each child entitled to free school meals due to low income.

It is necessary to apply for free school meals to be registered to receive this payment.

Child Winter Heating Payments

The Child Winter Heating Assistance payment of £214.10, which is an annual payment to help disabled children and young people heat their homes, will be paid automatically to families for anyone under 19 who receive the following qualifying benefits:

- The highest rate of the care component of Child Disability Payment or Disability Living Allowance for children
- The enhanced rate of the daily living component of Personal Independence Payment
- The enhanced rate of the daily living component of Adult Disability Payment

Young Carer Grants

Young people aged 16, 17 and 18 can receive a grant of £326.65 a year if they are caring for someone on average 16 hours a week who receives a disability benefit.

Young careers can apply if they are at school, in further education, employed or unemployed. People can apply once a year as long as they remain eligible. The payment is a cash benefit and people can spend it as they choose.

Young Patients Family Fund

If you have a child in hospital you can claim for the costs of travel and food through the Young Patients Family Fund. This is available to parents, primary carers and siblings under 18 when a baby, child or young person under 18 is receiving inpatient care, regardless of income. The Fund can cover transport to hospital once a day, meals and in some cases, accommodation.

Our AGM was held on Thursday 29 September 2022 at The Maitlandfield Hotel, Haddington. This was the first AGM that has been held face to face since the pandemic, and there was a good turnout.



Our Chair, Peter Ewart reflected on his role having served his five-year term. He highlighted that ELHA continues to be a leader in digital services which was key to helping to respond to the challenges of the pandemic, and that the Association remains the only housing association in the UK offering monthly rent discounts. Peter also highlighted the current Cost of Living crisis which he stated is very high up on the agenda for the Management Committee. Our Chief Executive, Martin Pollhammer gave a presentation on developments in some of our new digital services, including the launch of our new Rent Management system, a self-service tool for tenants to make their own repayment agreement without having to meet or speak to a member of staff.

Please watch out for a text message claiming to be from the Government, inviting you to apply for £400 discount from the Energy Support Scheme.

It's a scam!

Every household is entitled to this discount, but it will be paid directly to your energy supplier over 6 months from October 2022. You do not need to apply.

Most phone providers are part of a scheme that allows customers to report suspicious text messages for free by forwarding it to 7726.

If you forward a text to 7726, your provider can investigate the origin of the text and arrange to block or ban the sender, if it's found to be malicious.

You can also take a screenshot or screen recording of the text message and send it to the National Cyber Security Centre at report@phishing.gov.uk
