#### Social Security Scotland Update

The Best Start grant payments have increased from 1 April by 1%. The new amounts are:

- Pregnancy and baby payment (first child) increased from £600 to £606
- Pregnancy and baby payment (other children) increased from £300 to £303
- Multiple birth supplement increased from £300 to £303
- Early learning payment increased from £250 to £252.50
- School age payment increased from £250 to £252.50

#### By Phone

Action Fraud has issued a warning to the public about a National Insurance scam. The scam starts with an automated phone call stating that the person's National Insurance number has been compromised, and

asking them to press 1 to speak with someone to resolve the issue

Once connected, the scammers request personal information which can be used for identity theft.

#### By Text Message

A text message scam attempting to get internet baking details for HSBC accounts has been identified. People have received a text message pretending to be from HSBC, stating that a payment was attempted from a new device, and that if this payment was not the account holder, they should click on a link.

This link takes them to a page which looks like the log in page for the HSBC's internet banking. This enables scammers to harvest the log in information for accounts.

#### Garden Care Scheme

We provide a Garden Care Scheme to tenants who are aged over 70 or who have a disability which makes maintaining their garden impossible. The work is carried out by East Lothian Council, and due to a number of factors, the Scheme has been slow to get started this year, and now has a large backlog to work through.

Grass cutting for the Garden Care Scheme resumed on the 3rd of May. If you are on the Scheme, and your grass hasn't been cut yet, please get in touch with us so we can check in with the contractor. Unfortunately we can't say when your grass will be cut, as this depends very much on the weather.

#### Are you Missing Out on Pension Credit & a Council Tax Reduction?

New figures from Age Scotland reveal that older people on low incomes missed out on £88 million in Council Tax Reduction support last year. This is often due to also missing out on Pension Credit. It is estimated that at least 123,000 older households in Scotland are not claiming the Pension Credit they are entitled to which would make them eligible for full Council Tax Reduction.

If you're not claiming Pension Credit, and you think you may be eligible, you can call Age Scotland's 'Check in, Cash out' free entitlement check helpline

on 0800 12 44 222, or pop into your My Home account and fill in the Money Advice form (it's the button under your rent statement in your My Home account).

## School Age Payments -Update

Applications for the School Age Payment are now open to families who get tax credits or certain benefits and have a child who was born between 1 March 2016 and 28 February 2017. If you qualify for the School Age Payment, you'll receive £252.50 for each child born within these dates.

The new School Age Payment has not replaced the School Clothing Grant nor does it affect such payments in any way. If you want to apply for both benefits, you can.



## Housing First Project

A joint project between Women's Aid East & Midlothian (WAEML), East Lothian Council and ELHA, has received a two-year grant from the Scottish Government's Third Sector Homelessness Fund.



The funding will create East Lothian's very first Housing First project for women experiencing domestic abuse. Housing First provides ordinary, settled housing as the first response for people whose homelessness and housing insecurity is made harder by experiences such as trauma, addictions and mental health problems.

Housing First is backed by worldleading experts in the field of homelessness, human rights and housing. Women who are subjected to domestic abuse are some of the hardest to reach, often at the highest risk and, as such, require a specialist gendered and trauma informed response. There has been increasing recognition of the linked experiences of genderbased violence, homelessness and severe and multiple disadvantages.

Housing First for Women will provide a person-centred response, addressing all of the needs of the individual.



## New Complaint Procedure

We like to think that most of our tenants are happy with the services we provide but we know we don't always get it right, and there may be times when you need to make a complaint. No one should ever feel that they are 'being a nuisance' by complaining – we really welcome them! We use the feedback received through complaints to shape our services, and they help us to identify the areas we need to improve in.

We follow the Scottish Public Services Ombudsman (SPSO) Model Complaints Handling Procedure, and this has recently been updated. You can read the new Procedure and our most recent complaint report on **elha.com**, or we can send a copy out on request.

## **Estate Complaints**

We are currently receiving a higher than normal volume of complaints, mostly about the condition of gardens and communal areas, and about the level of service our new stair cleaning contractor is providing.

Our Housing Staff are still working from home and only carrying out essential visits, though we have increased our presence outside on the estates. We are trying to resolve all the issues that have been reported but this is taking us longer than it would normally do, so please bear with us.

Please know that if you report an issue, we make a record of it and will investigate the problem, but some of these matters may take time to resolve. For example, if you report that your neighbour has an overgrown garden, we will take the matter seriously and will try to work with them to get the garden tidied, but this is not always as easy as it sounds and can take us weeks or months to sort out. Similarly, if rubbish or items have been dumped in communal areas, staff will first contact tenants to try to find out who has done this before arranging the items to be lifted. Otherwise this means charging the costs of this work to everyone living in the stair rather than charging the person who actually did it.

Our new stair cleaning contract, which started on 1st April 2021, has generated quite a few complaints and we can only apologise for this; it is taking the new contractor a little time to adapt to our way of working. Our Housing Manager has recently met with the contractor to discuss all of your concerns and we have been assured that your complaints will be properly rectified and the service improved. Though this is a very basic cleaning service we do expect a good level of service from our contractor and we will be monitoring this contract very closely in the coming months.
